Executive Report/ Director Update with slides

OCCoE Director (Yesilada) provided Center updates, including working towards applying for additional grants with PSU Research Professor Tugrul Diam. OCCoE Operations and Fiscal Manager (Grant) provided financial updates including operational chart, budget allocation and expenditures, external support for OCCoE programs, funding expansion priorities, and next steps.

- Funds covering partnering university employees working on OCCoE
- WFD funds to be spent by October 2025
- Applying for 3-year expansion of federal earmark
- HECC funding for Oregon Tribes certificate program in progress
- NW Cyber Camp funding expanding
- Future plans for Cyber Range with help from State CISO

Associate Director Updates

Associate Directors from University of Oregon (Rejaie) and Oregon State University (Bobba) gave updates on program progress at each university.

- TSOC and high school mentorship program for minority students both in progress at UO, with university delays on vendor processes, hiring, and grant data collection requirements
- ORTSOC looking to expand from 11 clients to 20 by summer, making program accessible to online students and more hours, with constraints to personnel costs

Subcommittee Reports

Each Subcommittee Chair provided updates from their subcommittee meetings, and all Charters were approved by Executive Committee and the Council.

- Strategy & Policy (Sondenaa) discussed next steps for policies in Council member participation guidelines
- Finance (Wente-Chaney) indicated that financial report was covered in Executive Update
- Technology & Standards (Perez) confirmed as Chair and discussed plans for security evaluations over benchmarking as a role of this subcommittee

Old Business

The Council expressed a need for a deeper budget explanation

 Costs budgeting for TSOC, Certificate Program expansion, Cyber Range, Cybersecurity training for Secondary School Teachers, additional staff, interdisciplinary degree

New Business

Budget approved by Council.

Council members discussed opportunities to lobby in Salem to take cybersecurity stories to legislature as part of a greater need to utilize Council to have more impact on tasks where universities can't. Part of that impact can include using organizational support in Council to undertake ideas and provide facilitation, such as promoting existing frameworks like NCSR with CISA to provide security assessments throughout the state.

Executive Session

Pursuant to ORS 192.660 section 2(p), the Advisory Council held an executive session to consider matters relating to cybersecurity infrastructure and responses to cybersecurity threats.
